

PRIVACY POLICY

This page describes how to manage the site in relation to the processing of personal data of users who simply use it or provide personal information to take advantage of the services provided.

This notice is provided pursuant to section. 13 of D.Lgs.n. 196/2003 - Code regarding the protection of personal data to those who interact with web services by **LA NUOVA METALLURGICA S.R.L.** (hereinafter "writer"), accessible by internet starting from the page: <http://www.lanuovametallurgica.com> the home page of the official website of the writer.

The information is based on Recommendation no. 2/2001 that the European authorities for the protection of personal data, gathered by the Group established. 29 of Directive no. 95/46/CE, adopted on 17 May 2001 to establish minimum requirements for collecting personal data on-line and, in particular, the manner, timing and nature of the information that data controllers must provide to users when they connect to web pages, regardless of the purpose of the link.

Place of data processing

The treatments related to the web services of this website take place at the premises and are only handled by technical staff or others charged with occasional maintenance operations.

No data deriving from the web service is communicated or disseminated.

The personal data provided by users who request dispatch of informative material, offers, requests for services, are used only to perform the service or provision requested and are communicated to third parties only where this is necessary for the purposes of the law or is necessary to achieve the requested service.

Types of data processed

Navigation data

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the communication protocols of the Internet.

This information is not collected to be associated with identified, but by their very nature could, through processing and association with data held by third parties, allow users to be identified.

This category of data includes IP addresses or domain names of computers used by users connecting to the

site, URI (Uniform Resource Identifier) of requested resources, the time of request, the method used to submit the request to the server, the genre, the name and the size of the file obtained in reply, the numerical code indicating the status of the reply given by the server (successful, error, etc..) and other parameters regarding the operating system and computer environment user.

These data are used only to obtain anonymous statistical information on the site and to check its correct functioning and is deleted in about twelve months. The data could be used to ascertain responsibility in case of hypothetical computer crimes against the site or in conflict with the law.

Data provided voluntarily by the user

The optional, explicit and voluntary sending of electronic mail to the addresses indicated on this website entails the subsequent acquisition of the sender, necessary to respond to requests, and any other personal data included in the message.

Specific summary information will be progressively reported or displayed on web pages dedicated to particular services on request.

Data provided by lower

No data should be entered on the website without the consent of their parents or guardians. Cookies

No personal user data is acquired by the site.

The session cookies used in this site avoid the use of other technologies that could compromise the privacy of users' browsing and do not allow the acquisition of personal identification data.

Optional supply of data

Apart from that specified for navigation data, the user is free to provide personal data contained in the request forms to the writer to request the dispatching of informative material or other communications and / or requests otherwise.

Their absence can make it impossible to fulfill the request.

Method of treatment

Personal data are processed by automated tools for the time strictly necessary to achieve the purposes for which they were collected.

Specific security measures are observed to prevent the loss of data, illicit or incorrect use and unauthorized access.

Rights of interested parties

The subjects whose personal data refer have the right at any time to obtain confirmation of the existence or otherwise of such data and to know its content and origin, verify its accuracy or request its integration or updating, or correction (art. 7 of Legislative Decree no. n. 196/2003).

Pursuant to this Article shall have the right to request cancellation, transformation into anonymous form or blocking of data processed in violation of the law, and to oppose in any case, for legitimate reasons, to their treatment, by contacting the owner of the treatment.
